The ARTIST is engaged severally on the terms and entertainers already designated have agreed to be bound by said terms and conditions.

PAYMENT TO BE MADE AS FOLLOWS:

- 7. ARTIST agrees to pay \_\_\_\_\_% of the FULL FEES ENTERED within five (5) days of the engagement, if that percentage has not been paid directly by ABATE of Indiana Inc. as part of Item 6A (Deposit) or Item 6C (Direct Payment from PURCHASER).
- 8. If any members of said ARTIST are changed or replaced or if the ARTIST changes the group name, ARTIST is required to notify ABATE of Indiana, Inc., and ABATE of Indiana, Inc. shall have the right to cancel said ARTIST if it deems, in its sole discretion, that the change of members or name is material.
- 9. The agreement of the ARTIST to perform is subject to proven detention by sickness, accidents, riots, strikes, epidemics, Act of God, or any legitimate condition beyond their control.
- 10. The agreement of the PURCHASER to employ the ARTIST is subject to proven detention by sickness, accidents, riots, strikes, epidemics, Act of God, or any legitimate condition beyond their control.
- 11. If the ARTIST is unable to perform on the date of the engagement, ARTIST shall return any fees that have been paid to the PURCHASER.
- 12. This contract, and the terms and conditions herein, may be enforced by the PURCHASER, and the ARTIST who is a party to this contract or whose name appears on the contract.
- 13. All claims and disputes of any of the terms or conditions of this contract, including any disputes between the parties as to their respective obligations and responsibilities hereunder, shall be referred exclusively to binding arbitration with the American Arbitration Association, unless both parties agree to another arbitrator not affiliated with the AAA.
- 14. This contract, the parties' performance hereunder, and the relationship between them shall be governed by, construed, and enforced in accordance with the laws of the State of Indiana, without giving effect to the choice of law principles thereof.
